Maleeha has won acclaim across the US for her teaching and performing skills. She is known nationally by her peers, and travels frequently throughout the U.S. to teach and perform. She has been described as “a dancer’s dancer” “warm and accessible” “a master teacher and choreographer” “able to teach to multiple levels of experience while imparting important areas of technique,” “a true mentor.” Maleeha has performed professionally for nearly three decades in all the venues open to the belly dancer – from nightclubs and cabarets to festivals and theatres. She is the Artistic Director of **Kahraman Near East Dance Ensemble**. At home in Iowa, she teaches weekly classes from her own studio, the **Kahraman Dance Studio**. She studied extensively in both New York and Egypt with **Ibrahim Farrah**, **Mahmoud Reda** and **Ghassan Fadlallah** gaining proficiency in many of the folkloric dances of the Near East as well as Classic Orientale. She also holds a Master’s of Fine Arts Degree in Dance from the University of Iowa.
